Deconstruction of US diplomatic cables relating to Sweden

SWEDEN WANTS: Swedish Prime Minister Reinfeldt wants climate issues at the top of his domestic agenda.

SWEDEN WANTS: To become more like the United States and less socialist by reducing unemployment benefits, doing away with the wealth tax, and abolishing the value-based property tax and replacing it with a much-reduced local tax. Sweden also wants to sell 6 large state-owned business by 2011. These businesses are Civitas Holding AB which owns Vasakronan AB, Nordea Bank AB, OMX AB, Sveriges Bostadsfinansieringsaktiebolag SBAB, TeliaSonera AB, and V&S Vin & Sprit AB.

SWEDEN WANTS: To retain its commitment to multilateralism, with an emphasis on the roles of the United Nations and European Union, and values continued cooperation with NATO.

SWEDEN WANTS: To add more troops to its NATO Provincial Reconstruction Team in Afghanistan.

SWEDEN WANTS: To, with the United States, achieve a breakthrough in the development of alternative energy sources. This collaboration is called “The One Big Thing” or OBT.

SWEDEN WANTS: Turkey to join the European Union.

SWEDEN WANTS: Joint research with U.S. regarding hybrid engins for heavy trucks.

SWEDEN DOESN'T WANT: It's citizens to know that, with the United States, it is gathering extensive intelligence on its population.

UNITED STATES WANTS: To emphasize to Sweden that the United States will cooperate on alternative energy.

UNITED STATES WANTS: To continue to maintain the Swedish partnership regarding military and civilian intelligence organizations which are very important to the United States on issues like understanding events inside the Russian military and Iran's nuclear ambitions. This cooperation with Sweden also extends to the Swedish civilian population.

UNITED STATES WANTS: Sweden to take third-country nationals currently in US custody, as in Guantanamo detainees.

Summary: This is a very important cable. It is setting the stage for Sweden's newly elected Prime Minister to visit President Bush in Washington. It not only reflects the goals of the new Swedish government, it reflects a change in its relationship with the United States. The cable says the new Swedish government is "better-disposed toward working with the United States than its predecessor. Prime Minister Reinfeldt comes from a new political generation and is not bound by the same United States.-critical traditions." The United States views the emergence of the new center-right Swedish government to be more pro-American and pro-business.

Sweden wants to be like the United States. Within the European Union, Sweden often takes positions that coincide with our own on issues as diverse as the DOHA round, European Union enlargement and Turkey, Swift banking data privacy, and the European Union's relationship with Cuba.

Sweden's official security policy is non-participation in military alliances during peacetime and neutrality during wartime. However, according to the United States, this is LIE as the unofficial policy actively supports NATO and its role in leading the European Union's 1,500 troops-strong Nordic Battle group.

On gathering civilian intelligence the cable says "Due to domestic political considerations, the extent of this cooperation (with the US) is not widely known within the Swedish government and it would be useful to acknowledge this cooperation privately, as public mention of the cooperation would open up the government to domestic criticism."

The One Big Thing has made significant progress in several key areas. Among the most significant are: -- Negotiation (in progress) of a DoE/Sweden/Volvo joint research agreement regarding hybrid engines for heavy trucks; -- Commitment by Sweden's Chalmers University to host a Fulbright Distinguished Chair in Alternative Energy Technology; Chair to arrive in August 2008; -- Matching promising initiatives with venture capital, List of 30 promising Swedish alternative energy companies given to 18 United States Venture Capital firms interested in alternative energy investment; the meeting which took place on 4/19 in Stanford, California generated considerable interest;-- Participation of Swedish industry in an imminent contract awarded by DARPA to Swedish Biofuels AB for the development of jet fuel made from bio fuels; -- An agreement on second generation biofuels between the Swedish Energy Agency and the DOE will soon be ready for signature. Issues on visit include energy security and climate change mainly but also immigration from muslim countries, DOHA, Turkey & NATO, Russia & Estonia.

V&S Vin & Sprit AB , Absolute Vodka, was sold in 2008 to Pernod Ricard.

As of August 2010, Sweden promised to reduce investments in bank Nordea AB, telecom operator TeliaSonera AB, and mortgage lender SBAB. Profits would be channeled instead towards alleviating public debt.

Acronyms and Abbreviations explained:

The Doha Development Round or Doha Development Agenda (DDA) is the current trade-negotiation round of the World Trade Organization (WTO) which commenced in November 2001. Its objective is to lower trade barriers around the world, which allows countries to increase trade globally. As of 2008, talks have stalled over a divide on major issues, such as agriculture, industrial tariffs and non-tariff barriers, services, and trade remedies.

In 2010 the Bilderbergers think tank group, Peterson Institute for International Economics, said a DOHA agreement could boost world GDP by \$300-700 billion a year by opening up new trade in agriculture, manufacturing and services.

Swift Banking Data - A series of articles published on June 23, 2006, by The New York Times, The Wall Street Journal and The Los Angeles Times revealed that the Treasury Department and the CIA, United States government agencies, had a program to access the SWIFT transaction database after the September 11th attacks called the Terrorist Finance Tracking Program.

After these publications SWIFT quickly came under pressure for compromising the data privacy of its customers by letting a foreign government agency access sensitive personal data. The US and the EU attempted to get an agreement to allow sharing of the Swift, however, on February 11, 2010, the European Parliament has decided to

reject the interim agreement between the EU and the USA with 378 to 196 votes. One week earlier, the parliament's civil liberties committee already rejected the deal, citing legal reservations.

UNITED STATES WANTS: To give Sweden two Uzbek nationals for resettlement.

UNITED STATES DOESN'T WANT: To keep Uzbek Nationals: Samadov and Ysupov.

SWEDEN WANTS: United Nations High Commissioner for Refugees (UNHCR) to be involved

in the placement of SAMADOV and YUSUPOV.

SWEDEN DOESN'T WANT: Counterterrorism Coordinator Ambassador Cecilia Ruthstrom-Ruin

doesn't want Yusupov and Samadov, Uzbek Nationals from the United States Department of Justice.

Summary:

Two Uzbek nationals came to the United States on student visas and stayed. Uzbekistan wants them back to face criminal charges and has issued an Interpol Warrant.

The Uzbek's have been able to successfully use the American legal system to avoid being sent

back to Uzbek. However, one is a threat to American national security and the United States wants both

of them out of the United States. Sweden wants the UNHCR (United Nations High Commissioner for Refugees) to be involved so they can go through

the process as refugees seeking asylum etc., as they should. Clearly, these two men would be in

great danger if they were to be sent back to Uzbekistan. Sweden says they met their goals for accepting

refugees (Iraqi etc). Sweden had resettled 27,000 Iraqi's between 2006 and 2007, plus it is

willing to take in Guantanamo detainees.

SWEDEN WANTS: To keep diplomatic pressure on related to the Georgia missile incident and Kosovo.

SWEDEN WANTS: In regards to Kosovo, Carl Bildt wants a period of quiet even from the United States.

SWEDEN WANTS: The process to be allowed to work its way through undisturbed.

SWEDEN DOESN'T WANT: Croatian diplomat Miomir Zuzul to be the Europe's representative to Georgia.

Summary:

Ambassador Wood raised the Georgia missile incident with Foreign Minister Bildt, who said we need to keep diplomatic pressure on, but that Zuzul was not right

for OSCE's representative (Zuzul was implicated in the decision to go forward with the Croatian government's 1995 ethnic-cleansing Operation Storm); that he had told President Sakashvili that Georgia should let its friends handle this one. On Kosovo, Bildt said we need to keep quiet and let the process go forward.

SWEDEN WANTS: Logistical support in Baghdad for a secretive visit by Swedish Foreign Minister Carl Bildt.

UNITED STATES WANTS: Sweden to become more involved in United States mission in Iraq (Bildt visit seen as "positive change in Sweden's attitude towards Iraq.")

Summary:

Foreign Minister Bildt planned a two-day trip to Iraq, to be kept secret and not publicly announced until after he arrived. Sweden wanted to rely on the United States for security and possibly other logistics.

UNITED STATES WANTS: United States wants continued Swedish role in Afghanistan.

SWEDEN WANTS: Sweden wanted United States to provide Afghan testimony as to its (Sweden's) humanitarian role in Afghanistan, plus legal clarification of Serbian sovereignty and Kosovo's independence.

(Goran Lennmarker and Urban Ahlin, government and opposition leaders in the Swedish Parliament's Foreign Affairs Committee told the U.S. Chargé d'Affaires they both saw room for increases in the number of Swedish troops in Afghanistan.)

SWEDEN WANTS: Sweden [Ahlin] wants the United States to help publicize "the humanitarian role Sweden's troop's play."

In return for the Social Democrats' support of this Government proposed increase in May 2007,

the term of authorization had been shortened, to expire in December 2008,

meaning deployment and authorized levels would be up for review and re-authorization in the Fall of 2008.

SWEDEN WANTS: The Chargé d'Affaires requested assistance in providing United States legal interpretation of provisions of UNSCR 1244 dealing with the sovereignty of Serbia and independence of Kosovo. "Both Lennmarker and Ahlin said Sweden has serious concerns about the direction Russia is taking."

SUMMARY:

Ahlin requested “help in getting a senior Afghanistan government official to come to Sweden to relate humanitarian stories such as how the Swedish and NATO efforts are allowing girls to go to school, keeping the country from being taken over by drug lords, and keeping the Taliban from oppressing the people.”

(The Chargé d’Affaires officially requested assistance in responding to this request, by arranging for a senior Afghan official to so testify before the Swedish Parliament.)

“Regarding the possibility of Sweden sending JAS Gripen fighters to Afghanistan, Ahlin said the Social Democrats had told the Moderate-led Alliance government they would not agree to this mission. Afghans would not be able to distinguish Swedish planes from those of countries engaged in combat operations in Iraq, per Ahlin. (Note: The Swedish military continues to argue for a Gripen mission to Afghanistan)” “Ahlin said he disagreed with the go-slow

approach that Foreign Minister Bildt and the MFA are taking on the recognition of Kosovo (reftel).

At the same time, it was important for the government to be able to justify legally the position it takes on Kosovo's independence. Sweden is a legalistic society, and gives great deference to the UN.”

SUMMARY:

Economic Counselor discussed reftels demarche points with Swedish Inspectorate of Strategic Products, and the Deputy Director, Security Policy Department, Counter Terrorism Unit, Swedish Ministry for Foreign Affairs. [reftels SECSTATE A,B and C # 29096, 29464 and 29098 were not found.]

Documents were further shared with their colleagues, and appreciation was expressed for the list of financial institutions contained in Ref A, commenting, "This is very useful for us."

This was also shared with the Ministry of Justice colleagues, as well as with senior MFA colleagues who cover Iran, nuclear non-proliferation, and UN/global issues."

GOVERNMENT PERSONS/POSITION:

Inger Aseborn, Principal Administrative Officer, Swedish Inspectorate of Strategic Products - The National Inspectorate of Strategic Products controls Sweden's export of military equipment and products that can be used both for civilian and military purposes. It also monitors the provisions of the UN Convention on the Prohibition of Chemical Weapons.

SWEDEN WANTS: Swedish Armed Forces has indicated its desire on several occasions to deploy Medevac helicopters, JAS-39 Gripen aircraft and possibly additional soldiers in its PRT in Afghanistan.

SWEDEN WANTS: Sweden's Ministry of Defense wants to participate in the January-July 2010 NATO Response Force (possibly with land forces), however, the country's government is arguing about this within the parties. UNITED STATES WANTS: Sweden to provide NATO forces in Afghanistan with a battle ready Operational Mentoring and Liaison Team (OMLT).

UNITED STATES WANTS: Sweden to participate in NATO's Response Force from January through July 2010.

UNITED STATES WANTS: to thank Sweden for agreeing to host the International Compact with Iraq Conference.

SUMMARY:

This cable has been referenced several times in the media because it describes the warm and fuzzy relationship that Stockholm and Washington have. This is a scene setter cable for US Secretary of Defense, Gates, regarding the upcoming visit to Washington, DC by Swedish Minister of Defense Sten Tolgfors.

"The Ambassador has cultivated a close working relationship with Tolgfors from Tolgfors' prior job as Minister of Foreign Trade. Tolgfors went to high school in the United States and told the Ambassador he loves the United States and maintains friends there."

SWEDEN WANTS: America to grant export licenses for AESA radar to be installed on SAAB Gripen fighter planes (this would make Gripen attractive to the Norwegian air force).

UNITED STATES WANTS: To support Swedish proposals for enhanced Nordic cooperation – this is a cookie to get Sweden to back off of its request for the release of AESA.

UNITED STATES DOESN'T WANT: To release AESA to the Swedes at this time due to competition with US companies bidding for sales of fighter jets in Norway and Denmark.

SUMMARY:

The Swedes want to make their Gripen fighter jets more competitive and need the AESA to do so. The US does not want them to have AESA at this time because the Gripen is competing against Lockheed Martin and Boeing for sales in Norway and Denmark.

The United States clearly interfered with the bidding process in order to sell Norway Lockheed Martin's F-35 jets, costing the Swedes a lot of money. Denmark has postponed buying fighter jets.

UNITED STATES WANTS: Sweden to accept a Palestinian Guantanamo refugee.

SUMMARY:

The United States was advised to make formal request via Swedish Embassy in Washington to consider accepting a Palestinian Guantanamo refugee. Advised that the request should be formal, include proof of why he would be persecuted in Israel if returned there, and may not be acceptable to all in Swedish political process despite public support for another refugee that had previously been denied asylum.

SWEDEN WANTS: To meet United States requirements to continue to participate in the enhanced Visa Waiver Program (i.e. for its nationals to be able to travel freely to the United States).

SWEDEN DOESN'T WANT: A formal bilateral arrangement for sharing information it holds on terrorist suspects that it has to present to the Swedish Parliament. ("the current Swedish political climate makes any formal terrorist screening information agreement highly difficult"/" particularly sensitive time politically in Sweden for issues involving government surveillance and affecting personal privacy")

SWEDEN DOESN'T WANT: To participate directly via access to the United States' Terrorist Suspect Database

UNITED STATES WANTS: Access to information about terrorist suspects, asylum seekers held by other governments, whether that bypasses these countries' own political processes or not. Continued Swedish participation in the enhanced Visa Waiver Program (easy travel to the United States for Swedish citizens) dependent on such access to information held by Sweden being provided.

UNITED STATES DOESN'T WANT: To negotiate any such formal arrangements European Union-wide, interprets these matters as "third pillar" i.e. as falling under the remit of individual member states.

SUMMARY:

NOTE - This cable is generating a stir in Sweden.

Meeting between United States representatives of the Homeland Security Program with the Swedish Ministry of Foreign Affairs and Ministry of Justice about sharing personal information for "terrorist screening". Detailed memorandum about a process for sharing information tabled by the American side for discussion, and Swedish side expressed willingness to "informally" continue feeding information to the US although expressed doubt that they themselves were a terrorist target.

*Reader's note: The Chair of Sweden's Parliamentary Justice Committee has demanded clarification of the arrangements discussed in this meeting; there are concerns that Sweden may be in breach of its own Constitution by volunteering the information of its own nationals in this way:

The United States wants Sweden to officially adopt HSPD-6 (see below).

Sweden knows that the People will not go along with this agreement, so it prefers to continue to comply with the program but only in secret (on an informal level).

Sweden wondered whether the putative advantages of an HSPD-6 agreement for Sweden would be offset by the risk that these existing informal channels, which cover a wide range of law enforcement and anti-terrorism cooperation, would be scrutinized more intensely by Parliament and perhaps jeopardized. In light of the ongoing controversy over Sweden's recently passed surveillance law, it would be politically impossible for the Minister of Justice to avoid presenting any formal data sharing agreement with the United States to Parliament for review. The effect of this public

spotlight could also place other existing informal information sharing arrangements at jeopardy.

HSPD-6 – “ To protect against terrorism it is the policy of the United States to

- (1) develop, integrate, and maintain thorough, accurate, and current information

about individuals known or appropriately suspected to be or have been engaged in conduct constituting, in preparation for, in aid of, or related to terrorism (Terrorist Information); and

(2) use that information as appropriate and to the full extent permitted by law to support

The Greek Political Director made a very good point about the Middle East, "no one in the Middle East thinks Iran will actually use nuclear weapons against Israel." Rather, they think Israeli concerns over the Iranian nuclear program are motivated by a desire to not lose their strategic dominance.

The main reason for stopping Iran's nuclear plans is that it would set a bad precedence for the rest of the world. If the EU and the US allow Iran to develop nuclear weapons then there would be nothing to stop other countries in developing nuclear weapons.

Holbrooke, Peter Galbraith, and Barnett Rubin in Istanbul. Their discussion covered all possible scenarios in Afghanistan and each was profoundly difficult. Bildt said that if the international community does not influence Afghanistan in the right way, the Afghan political system will fracture and the outcome will be worse than under the Taliban system. Bildt opined that the Taliban will never conquer the country--even if the international community pulls out--but could significantly disrupt and destroy Afghanistan. If the Pashtuns fall out with the others and start fighting the Northern Alliance over election results, then the situation will seriously worsen. Bildt said that the situation in Afghanistan is unlike the situation in the Balkans or Caucasus because all of the Afghan actors are fighting for power in Kabul and lack secessionist desires. All international actors need to unite and insist that "we won't play games."

SWEDEN WANTS: to expand the U.S.-E.U. alternative energy partnership to the E.U. level, to launch this effort ("The Next Big Thing," or NBT) at the U.S.-E.U. summit in November

SWEDEN DOESN'T WANT: Sweden "does not want to see alternative technology efforts bogged down by geo-political discussions of the security side of the energy issue," i.e., if that would result from NBT being part of U.S.-E.U. Energy Council, or Next Best Thing "being run through Brussels," via the Transatlantic Economic Council

UNITED STATES WANTS: Next Big Thing distilled so that it could be incorporated into other countries' systems , Olofsson responds that "Sweden could arrange meetings to connect companies as part of the US-EU

alternative energy partnership, and even co-finance projects if that is needed")

UNITED STATES(or at least embassy) Wants: to comply with Swedish request for U.S. representation at E.U. meetings.

UNITED STATES DOESN'T WANT: US does not want to comply with Sweden by attending the Alternative Energy conference. Invitations to attend declined by: Secretary of Energy, Chu; Deputy Secretary of Energy, Poneman; Assistant to the President for Energy and Climate Change, Browner; Secretary of Labor, Solis; Secretary of Health, Sebelius; Secretary of Homeland Security, Napolitano. Invitations still pending: Secretary Clinton; Deputy Secretary, Lew; Special Envoy, Stern

SUMMARY: Sweden is a proven leader in this area having grown its economy 46% between 1992-2008, while reducing Greenhouse Gas Emissions by 9%.

Deputy Prime Minister, Swedish Official Maud Olofsson would like to have a Senior US Official actually attend meetings. The request for attendance from a Senior USG Official was a direct plea for help. She said she is hopeful that the USG will be able to demonstrate the importance it attaches to the bilateral links in the Alternative Energy area by sending an official.

Second Part of cable dealing with File Sharing

UNITED STATES WANTS: Sweden to improve its efforts against illegal file sharing, pointing out that Sweden and the U.S. both have a lot to lose as "knowledge-based economies"

UNITED STATES WANTS: a public debate about illegal file sharing being theft from artists

SUMMARY: Olofsson's Center Party is the Swedish political party least supportive of U.S. pressure to crack down on illegal file sharing. Olofsson maintains that the problem should be addressed not only through legislation, but through the market providing an affordable product, while noting that Nokia and Ericsson have introduced new sharing products which pay artists.

SWEDEN (Bildt) WANTS: (In order to justify stronger Iran sanctions) Information on companies in key industries where European goods cannot easily be replaced.

SWEDEN WANTS: U.S. to demonstrate that Europe will lose credibility if it allows Tehran to manipulate the West.

UNITED STATES WANTS: Future additional Swedish troop deployments to Afghanistan.

UNITED STATES WANTS: To help Bildt help Prime Minister Reinfeldt achieve his goals, so that Bildt will have more clout "to lobby for U.S. priorities."

Summary: This is a detailed, very personal, analysis of Foreign Minister Carl Bildt; almost all of the policies, attitudes, and actions described are his, not necessarily Sweden's as a whole. In August 2009, after this report was written, Mehdi was arrested again at the Afghan border. This time he was blamed for an uprising at the Pakistani prison where he is being kept. 17 people were killed during this uprising. He has since been released and returned to Sweden.
